CONDITIONS FOR REGISTRATION - TOURNAMENT RULES - FEES

(31 August 2014 edition, the organisation reserves the right to modify the terms and conditions of the current regulations)

11 A-SIDE AND 5 A-SIDE TOURNAMENT

EUROLAWYERS is a Football tournament reserved for European lawyers.

I. CONDITIONS FOR REGISTRATION

1.1. Team registration

1.1.1. The tournament is intended for football teams from Bar Associations, groups of lawyers and law firms.

1.1.2. Each team must have between 13 and 26 football players for 11 a-side teams, and between 6 and 10 football players for 5 a-side teams.

1.2. Qualification to play

1.2.1. Each team must take account the following conditions:

Apart from the exceptions mentioned below in paragraph 1.2.2 participants must:

- be registered lawyers (or formerly registered) at the bar of the country of the team concerned;
- hold legal or judicial degrees where being registered at the Bar of the country concerned is not foreseeable
- be employees of law firms which have a minimum of 100 lawyers, limited to 2 per team. Employees must be over 30 years old (born before 31/12/1987) in the CLASSIC and FIVE tournaments, and over 35 years old for the MASTER's tournament (born before 31/12/1982)
- be student lawyers or trainee lawyers, older than 22 years old (born before 31/12/1995), limited to 2 per team, for the Classic and «Five» tournaments.

1.2.2. Principle Exceptions

- exceptions may be made, limited to 2 per team (football 11) and 1 per team (Football 5), for non-lawyers belonging to the legal or judicial family (magistrates, court bailiffs, notaries, holders of a Masters in rights, accountants).
- no exceptions may be granted for non-lawyers who are playing or have played professional, semi-professional football or played for any club for remuneration.
- to be admissible, exemption requests should be addressed to Mr. Vincent PINATEL, lawyer and founder of Mundiavocat no later than 1 month before the start of the tournament.
- all the conditions specified above, related to exemptions are necessary but not are sufficient in themselves to secure a waiver. The final decision to grant an exemption will be made by the Commission of exemptions which is composed of Mr Vincent PINATEL (lawyer founder) and Mr. Pierre CHICCO (tournament director).

1.2.3. Composition of the teams

Masters Tournament:

- Lawyers over 35 (born before 31/12/1982), and above mentioned
- 5 lawyer players over 30 (born before 31/12/1987)
- 2 exempt players over 35 (born before 31/12/1982)

Classic Tournament:

- Lawyers - no age limit, as mentioned above
- 2 exempt players over 30 (born before 31/12/1987)

Five a side Tournament:

- Lawyers - no age limit, as mentioned above
- 1 exempt player over 30 (born before 31/12/1987)

1.3. Terms of registration

1.3.1. Each player must provide the following documents no later than 4 weeks before the start of the tournament:

(a) Professional certification:

- For lawyers: a photocopy of the lawyer's card;
- For student lawyers, trainee lawyers: a copy of their lawyer's school registration certificate or equivalent;
- For exempt non-lawyers: a certificate demonstrating that they belong to their profession confirming their activity, in addition to a certificate of honour signed by the team captain certifying that the player seeking exemption not and has never has been employed by a professional or semi-professional football club;

(b) A recent medical certificate (less than one year) authorising the practise of football in competition under the conditions of Mundiavocat (5-7 matches from 60 to 70 minutes 8 days), conforming to the model provided by the organisers;

(c) a colour id photo

(d) a photocopy of a passport or identity card.

1.3.2. No additional player may register and so establish a license, during the competition.

1.3.3. All players will present on arrival prior to the tournament, the original professional certifications required.

1.3.4. No accreditation will be issued to teams who have not fully paid their registration and accommodation fees and / or are unable to present the required documents.

1.3.5. The organisers, impartially and in accordance with the rules laid down, will be the sole arbiters in the granting or refusal of licenses. Consequently participants, will have no access to individual certification files for verification purposes, before or during the tournament.

1.4. Infractions

Non-compliance with the rules on the qualification of participants, during the tournament, will lead, among other things, to the exclusion of the players concerned. The disciplinary committee's decisions are final.

1.5. Complaints

Team captains wishing to put in train sports or administrative claims must do so in writing. The competent authority (the Organising Committee or Disciplinary Committee) undertakes to respond within 24 hours.

II. REGISTRATION FEES

The participation fees for the 7th edition of l'EUROLAWYERS consists of:

- Registration fees per team
- Accommodation fees per person

2.1. Registration fees per team: FOOTBALL 11 A-SIDE: 3,000 € // FOOTBALL 5 A-SIDE: 1,200 €

These fees include: all expenses for the organisation of the tournament, football grounds, balls, referees (3 per game), delegates, water, medical assistance, cups, trophies, medals.

2.2. Accommodation costs and participation costs per person

Rates per person based on a double or twin room shared by two people.

- dinner
- repatriation
- assistance
- administrative costs.

These prices do not include:

- transportation to Maribor and back;
- airport and land transfers;
- personal expenses (telephone, minibar, kit washing, meals and drinks);
- tourist tax payable at the hotel;
- cancellation insurance.





2.3. Accommodation is mandatory for all participants

Given the agreements made with local hoteliers and their willingness to organise the housing of the teams in the same hotels, teams must make their reservations through the organisation. Indeed, in order to have the necessary quota of rooms in organising l'EUROLAWYERS, we make non-refundable payments to the hotels concerned. Thank you for your understanding.

WARNING:

- It is not possible to participate in the Eurolawyers without using hotels pre-reserved by CSO
- Please do not make reservations at other hotels, otherwise you may not attend the Eurolawyers.
- This condition is not negotiable.
- Only lawyers from Slovenian teams may have an exemption from this rule.

2.4. Payment of registration fees for the tournament, hosting fees and various services.
